# **Privacy Policy**

This Privacy Policy ("Policy") applies to www.hurleywrite.com, and Hurley Write, Inc. ("Company") and governs data collection and usage. # **Collection of your Personal Information**

In order to better provide you with products and services offered, the Company may collect personally identifiable information, such as your:
